4. It undertakes to respect the Guidelines for the Circuit, attached to this declaration, of which the undersigned has read and to follow the instructions given by the Scuderia Speed Race A.S.D. and Kartodromo S.r.L.

I ask

to be able to access the Lignano Circuit track located in Precenico, Via Valle Hierschel 2, to carry out a free non-agonistic / competitive test and to this end declares:

- A)** To be perfectly aware that the request for access authorization only concerns the right to use the circuit, not exclusively and simultaneously with other users and categories for the whole period of free trial or recreational play, without any obligation to part of Scuderia Speed Race ASD and Kartodromo S.r.L. based in Precenico in Via Valle Hierschel 2, to provide light or flag service for the medical and fire service services.
- B)** To have personally accurately ascertained the current state of the track.
- C)** To be fully aware of the current regulations made available on the track and in the kart track or downloadable from the website www.lignanocircuit.com, which during the free practice or recreational entertainment event is obliged to comply with the aforementioned regulation as well as all further provisions possibly given in the course of the same organized by Scuderia Speed Race ASD and Kartodromo S.r.L. o from employees and / or collaborators. In the event of a recreational / recreational event such as Gara Renting Kart or Motorbike organized by Scuderia Speed Race A.S.D. o Kartodromo srl, to accept the regulations that will be exposed before and during the event.
- D)** To assume any responsibility for damage, physical and / or property, derived from Scuderia Speed Race A.S.D. and Kartodromo S.r.L. or to any third party due to the failure by the undersigned of the regulation and / or the provisions in point C.
- E)** To be perfectly aware of carrying out a dangerous activity and accepting all the risks, declaring in perfect condition of health and in possession of the authorization of law enabling the guide, valid and effective.

- L)** That the own vehicle or rented at Scuderia Speed Race A.S.D. and Kartodromo S.r.L. , led by the undersigned is perfectly suited to the test that is intended to be carried out and that the undersigned has the psycho-physical-aptitude abilities to take the lead of the same and to face and sustain a safe conduct of the test.
- M)** This declaration is valid for all uses of the runway, in the case of issuing the card to the registrant for several entries.
- N)** The registrant recognizes as his means of proof the use of any images taken from video footage with the existing instruments on the plant.
